CITY ORDINANCE NO. 20<sup>VN</sup>  
December 9, 1986

AN ORDINANCE AMENDING ORDINANCE NO. 147, SERIES OF 1963, "AN ORDINANCE WHICH PROHIBITS MINOR PERSONS, BELOW TWENTY ONE YEARS OF AGE TO BE OUT OF THE PREMISES OF THEIR RESIDENCE OR EMPLOYMENT AFTER 9:00 O'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE FOLLOWING MORNING AND PROVIDING FOR ITS PENALTY", SO THAT AS AMENDED, THE SAME SHALL READ AS FOLLOWS:

"AN ORDINANCE WHICH PROHIBITS MINOR PERSONS BELOW EIGHTEEN YEARS OF AGE TO BE OUT OF THEIR TEMPORARY OR PERMANENT RESIDENCE AFTER 10:00 O'CLOCK IN THE EVENING AND BEFORE 3:00 O'CLOCK IN THE MORNING."

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - It shall be unlawful for any person below 18 years of age to be out of his temporary or permanent residence after 10:00 o'clock in the evening and before 3:00 o'clock in the morning.

Section 2 - For purposes of this ordinance, a siren blast shall be sounded at 9:45 in the evening as a warning signal to be followed by another siren blast at 10:00 o'clock in the evening for the implementation of this ordinance.

Section 3 - The provision of Section 1 shall not apply to those minors who are out of their residence with their parent or guardian or any responsible relative who may vouch for their character and behaviour; neither will said provision apply to minors who are out of their residence or place of employment upon a written authority from their parent, guardian or employer as the case may be, stating in said written authority the date of issuance, the name of the minor, his or her and the parent's guardian's or employer's address, name and signature and the purpose of the minor's being out. Should the written authority be for more than five (5) days, a copy of the same should be furnished the Police Department.

Section 4 - Penalties: - Violation of Section 1 hereof shall subject the offending minor to detention in the Bacolod City Jail in accordance with law on detention for minor offenses. A second offense shall be punished by a fine of FIFTY PESOS (P50.00) plus judicial cost with subsidiary imprisonment in case of insolvency, the same to be computed in accordance with the provisions of the Revised Penal Code, and the third and subsequent offenses shall be punished by imprisonment of TEN (10) days straight penalty of a fine of ONE HUNDRED PESOS (P100.00) at the discretion of the Court.

Section 5 - This ordinance repeals or modifies accordingly all ordinances or parts of ordinances which are in conflict herewith.

Section 6 - This ordinance shall take effect immediately upon approval.






