CITY ORDINANCE NO. 25^d
MARCH 10, 1987

AN ORDINANCE AMENDING SECTION 4, PARAGRAPH A, NUMBER 2, OF CITY ORDINANCE NO. 17, SERIES OF 1986, WHICH PERTAINS TO THE WAITING STATIONS OF PUJs PLYING THE ROUTES TANGUB-HIGHWAY/BARRIO-CENTRAL MARKET; TANGUB-LIBERTAD; TANGUB-BANAGO; TANGUB-BATA, TANGUB-SHOPPING; TANGUB-MANDALAGAN, SO THAT AS AMENDED, THE WAITING STATIONS OF PUJs PLYING THESE ROUTES SHALL BE TRANSFERRED TO: FRONTING US COMMERCIAL CONSTRUCTION SUPPLIES TO BALLESTEROS STREET, ALONG GATUSLAO STREET (WESTERN PORTION) WITH NOSE FACING SOUTH IN PARALLEL POSITION.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - Section 4, paragraph A, Number 2, of City Ordinance No. 17, Series of 1986, which pertains to the waiting stations of PUJs plying the routes Tañgub-Highway/Barrío-Central Market; Tañgub-Libertad; ~~Tañgub-Banago; Tañgub-Bata; Tañgub-Shopping; Tañgub-Mandalagan~~ ^{is hereby amended} so that as amended, the waiting stations of PUJs plying these routes shall be transferred to: Fronting US Commercial Construction Supplies to Ballesteros Street, along Gatuslao Street (Western Portion) with nose facing south in parallel position.

Section 2- This ordinance shall take effect upon approval.


