CITY ORDINANCE NO. 27
July 28, 1987

AN ORDINANCE CREATING A TRAFFIC ENFORCER UNIT FOR THE CITY OF BACOLOD AND ITS FUNCTIONS AND APPROPRIATING CERTAIN SUM OF MONEY FOR THIS PURPOSE.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1. - The City of Bacolod shall create a Traffic Enforcer Unit to be composed of not more than Twenty five (25) members;

Section 2. - The Traffic Enforcer Unit shall be directly under the supervision of the Bacolod City Police Station and/or its duly designated Officer/s, representative/s and shall be responsible for their training, assignments and such related duties and functions as the Bacolod Police Station may require;

Section 3. - Members of this Unit shall be appointed by the City Mayor from among the Barangay Tanods of Bacolod City, who possess the following qualifications:

- a. Must be a citizen of the Philippines;
- b. Must be a person of good habits and moral conduct;
- c. Must be of sound mind and body;
- d. Must be at least a high school graduate but preference shall be given to applicants with higher educational qualifications, unless otherwise specifically required thereon;
- e. Must not have been dishonorably discharged from military/ police service or dismissed for cause from any civilian position in the government;
- f. Must have no criminal record;
- g. Must not be less than 21 years or more than 40 years of age at the time of appointment; and
- h. Must be at least 162.54 (5'4") height and 58 kilos (128 lbs.) in weight.

Section 4. - Prospective members of the Traffic Enforcer Unit must undergo and pass the training requirements at the Bacolod Police Academy as prescribed by the Station Commander of the Bacolod Police Station;

Section 5. - Employment status of members of this Unit shall be on a contractual basis for a three-month period, renewable for a similar period of time;

Section 6. - The basic compensation of the members of this Unit shall be ₱26.35 plus ECOLA of ₱20.40 per day and clothing allowance of ₱300.00 for every six (6) months of services;

Section 7. - The Traffic Enforcer Unit shall direct and maintain the orderly flow of traffic and shall enforce all traffic ordinances and/or laws and regulations of the City of Bacolod;

Section 8. - The members of the Traffic Enforcer Unit are hereby authorized to enforce City Traffic Ordinances rules, laws and regulations on any city streets/avenues only, until such time that they be deputized by the Land Transportation Commission to enforce national traffic laws, rules and regulations.

Section 9. - That the sum of THREE HUNDRED THOUSAND PESOS (P300,000.00) is hereby appropriated to cover the compensation and maintenance of the unit for the period from May 1 to December 31, 1987 retroactive, to be taken from Unappropriated Surpluses;

Section 10. - This ordinance shall take effect immediately upon approval.






