CITY ORDINANCE NO. 29 ✓  
August 18, 1987

AN ORDINANCE IMPOSING A CURFEW FROM 12:00 O'CLOCK MIDNIGHT TO 4:00 O'CLOCK IN THE MORNING.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - That a curfew be maintained and enforced throughout the City of Bacolod between the hours of twelve midnight and four o'clock in the morning and that between these hours and during the effectivity of this ordinance no person in the City of Bacolod shall be allowed to move about outside his or her residence unless he or she is authorized in writing to do so by the Committee on Curfew as duly constituted by Sangguniang Panlungsod Resolution No. 188, current series, and in coordination with the Office of the Mayor and the Bacolod Police Station.

Section 2 - Any person who violates this ordinance shall be arrested and forthwith taken into custody and kept within the premises of the nearest INP precincts or station and shall be released not later than six (6) hours from the time of his or her apprehension unless there are valid reasons or ground for his or her continued detention.

Section 3 - For purposes of this ordinance, a Committee on Curfew shall be created to undertake the processing of curfew pass applications and issuance of the required curfew pass for persons or entities whose activities require their presence during the prohibited hours aforementioned as determined by the said committee.

Section 4 - The aforementioned curfew pass application shall contain a certification of the applicant's employer, if any, or the Barangay Captain of the place of residence of the applicant stating the necessity of the issuance of the said pass in favor of the aforementioned applicant. Group passes shall be issued setting forth all the circumstances pursuant to the guidelines laid down by the Committee on Curfew.

Section 5 - This ordinance shall be valid and enforceable for a period of Sixty (60) days from its approval and may be renewed for the same period as circumstances may warrant as may be determined by the Sangguniang Panlungsod upon the recommendation of the City Mayor.

Section 6 - This ordinance shall take effect immediately upon approval.






