CITY ORDINANCE NO. 36 *V*
October 27, 1987

AN ORDINANCE DESIGNATING A PORTION OF RAMOS STREET, NORTH PUBLIC MARKET SIDE (RIGHT SIDE FACING NORTH) SIX (6) METERS FROM THE INTERSECTION OF BURGOS AND RAMOS STREETS, BACOLOD CITY, AS WAITING STATION FOR ABKASA AND BANAGO BOUND PASSENGER JEEPNEYS.

Be it ordained by the Sangguniang Panlungsod of Bacolod City in session assembled, that:

Section 1 - A portion of Ramos Street, North Market side (right side facing north) six (6) meters from the intersection of Burgos and Ramos Streets, Bacolod City, is hereby designated as waiting station for ABKASA and Banago bound passenger jeepneys.

Section 2 - Parking shall be in a diagonal position 33 degrees angles nose out.

Section 3 - The Traffic Division of the Bacolod Police Station, is hereby empowered to promulgate rules and regulations in the allocation and designation of the parking area for the ABKASA and Banago bound passenger jeepneys, respectively. Such rules and regulations shall be immediately submitted to the Sangguniang Panlungsod, Bacolod City for its information.

Section 4 - Any person violating this ordinance shall be fined the sum of P50.00 but not exceeding P100.00, or an imprisonment of 15 days but not exceeding 30 days for the first offense; P100.00 but not exceeding P150.00 or an imprisonment of 30 days but not more than 45 days for each succeeding offense, or both such fine and imprisonment at the discretion of the Court.

Section 5 - All other ordinances inconsistent with the provisions of this ordinance are hereby modified and/or repealed.

Section 6 - This Ordinance shall take effect immediately upon its approval.
