CITY ORDINANCE NO. 37<sup>r</sup>  
NOVEMBER 10, 1987

AN ORDINANCE CREATING A NEW BARANGAY IN THE CITY OF BACOLOD TO BE KNOWN AS BARANGAY PAGLAUM.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - A new barangay to be known as Barangay Paglaum composed of:

1. Paglaum Village
2. Sitio Buri
3. Hda. Guanzon
4. Hda. Hojilla
5. Hda. Tanalgo & Miranda
6. Hda. Green Farm (Gonzaga)
7. Hda. Nieves
8. Hda. De Leon
9. Hda. Garcia
10. Hda. Fortaleza
11. Hda. Martir
12. Hda. Cuison
13. Hda. Arceo-Ramos
14. Hda. Montinola and
15. Mabesa Subdivision

with a total population of more than TWO THOUSAND (2,000) and with a total land area of 750.2313 hectares more or less, is hereby created.

Section 2 - A plebiscite to be participated in by the residents of the areas enumerated in Section 1 hereof shall be held on February 27, 1988.

Section 3 - The City Engineer, in coordination with the City Planning and Development Office, is hereby empowered to incorporate this new barangay in the map of the City of Bacolod upon approval of this ordinance.

Section 4 - A new set of barangay officials shall be elected and/or appointed in accordance with existing laws, rules and regulations.

Section 5 - This ordinance shall take effect upon approval.


