CITY ORDINANCE NO. 42 ✓
January 5, 1988

AN ORDINANCE AMENDING SECTION 2 (d), SECTION 2 (e) AND SECTION 4 OF CITY ORDINANCE NO. 38 DATED NOVEMBER 24, 1987, "AN ORDINANCE REGULATING THE OPERATION OF VIDEO COMPUTER GAMES WITHIN THE CITY OF BACOLOD AND FIXING THE AMOUNT OF TAX TO BE COLLECTED BY THE CITY GOVERNMENT OF BACOLOD."

Be it ordained by the Sangguniang Panlungsod of Bacolod in session assembled, that:

Section 1 - Section 2 (d), Section 2 (e) and Section 4 of City Ordinance No. 38 dated November 24, 1987 are hereby amended, so that as amended, the same shall read as follows:

Section 2 (d) - Failure on the part of the permittee to pay the said fee within five (5) days from due date shall subject the said permittee to a surcharge of FIVE PESOS (P5.00) per day.

Section 2 (e) - Failure on the part of the permittee to pay the fee on the sixth day shall immediately subject the same to a fine of ONE THOUSAND PESOS (P1,000.00) and/or the revocation of his business permit.

Section 4 - Except on Saturdays, Sundays and non-working public holidays, video computer parlors, stores, shops and establishments engaged in the lease of the aforementioned machines shall be open to persons 16 years of age and below not earlier than 4:00 o'clock in the afternoon and not later than 7:00 o'clock in the evening. Any violation of these provisions shall immediately subject the permittee to a revocation of his business permit and/or a fine of ONE THOUSAND PESOS (P1,000.00).

Section 2 - This ordinance shall take effect immediately upon its approval.
