CITY ORDINANCE NO. 44 ✓

AN ORDINANCE CREATING A NEW BARANGAY IN THE CITY OF BACOLOD TO BE KNOWN AS BARANGAY CAPITOL HEIGHTS.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - A new Barangay to be known as Barangay Capitol Heights which was formerly within the jurisdiction of Barangay Villamonte, is hereby created, bounded as follows:

NE : by Vito Creek; on the

SE : by common boundary of Lots 1205 and 1372 (Greensville Subd.) Lot 1071 and Lot 1641 (Capitol Hills Subd.); and on the

SW : by Burgos Street Extension intersecting Magsaysay Avenue; and on the

NW : Along Magsaysay Avenue intersecting Mandalagan Creek, then going westward along Mandalagan Creek intersecting Vito Creek, with the exception of Barangay Montevista (PHHC).

with a total land area of ONE HUNDRED FIFTY FIVE THOUSAND NINE HUNDRED SEVENTY (155,970) SQUARE METERS, more or less.

Section 2 - For this purpose, a plebiscite to be participated in by the residents thereat shall be held on March 27, 1988 to be guided by Rules and Regulations Implementing the Local Government Code, Batas Pambansa 337, Rule II-B, Section 12, to wit:

"B. CREATION OF BARANGAYS

Section 12. Creation. - A barangay may be created by ordinance passed by the Sangguniang Panlungsod/Panlalawigan in which it is located, out of a mother barangay or from two or more barangays merged together.

In the plebiscite required for such creation, only the registered qualified voters of that portion of the mother barangay sought to be created into a new barangay or the existing barangays sought to be merged, may vote on the issue."

Section 3 - The City Engineer in coordination with the City Planning and Development Office, is hereby directed to incorporate this new barangay in the map of the City of Bacolod upon approval of this ordinance.

Section 4 - As a new barangay, there shall be a new set of barangay officials who shall be elected and/or appointed in accordance with existing laws, rules and regulations.

Section 4 - This ordinance shall take effect upon approval.
