CITY ORDINANCE NO. 54 ✓
October 4, 1988

AN ORDINANCE AMENDING ARTICLE 4, SECTION 6 AND ARTICLE 5, SECTION 1 OF CITY ORDINANCE NO. 47, AN "ORDINANCE ALLOWING AND REGULATING THE OPERATION OF TRICYCLE OTHERWISE KNOWN AS 'TRISIKAD', PRESCRIBING THE FEES, RULES AND REGULATIONS FOR ITS OPERATION."

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - Article 4, Section 6 and Article 5, Section 1 of City Ordinance No. 47, is hereby amended by inserting between Subsection Letters I and J, hereinafter known as Subsection J, to wit:

J. BARANGAYS 23, 24, 25, 26, 27, 28, 29, 30, 31, 32 and 33

1.0) From any point of these barangays toward the junction of Lacson Street using Galo, Rizal, Gonzaga, Luzuriaga, San Sebastian and Rosario Streets. The terminal/waiting stations is 20 meters before the junctions of these streets and Lacson Street;

1.1) Toward Libertad (South) Market using Mabini Street and other subdivision roads, leading to Libertad Street. The terminals waiting station is the junction of Doña Juliana and Libertad Street;

1.2) Toward Burgos (North) Public Market, using Mabini and Galo Streets, and other subdivision roads connecting Rizal and Gonzaga Streets toward Hilado Streets. The terminal/waiting station is the junction of Hilado-Galo Streets, near the BAC-UP Police Sub-Station;

1.3) Toward West Negros College using Galo Street and Parreño Avenue. The terminal/waiting station is the junction of these streets

ARTICLE 5, Section 1, is amended by adding after sub-section 1.8 by adding the following, to wit:

1.9) Aquino Drive from the junction of Lacson Street until the junction of Narra Avenue Extension.

Section 2 - This ordinance shall take effect fifteen (15) days from date of publication.


