CITY ORDINANCE NO. 56 ✓
February 2, 1989

AN ORDINANCE AMENDING ARTICLE 5, SECTION 10 OF CITY ORDINANCE NO. 47 WHICH STATES: "THE USE OF EARPHONE BY THE DRIVER WHILE DRIVING ATTACHED TO STEREO/RADIO CASSETTE IS STRICTLY PROHIBITED."

Be it ordained by the Sangguniang Panlungsod of Bacolod in session assembled, that:

Section 1 - Article 5, Section 10 of the City Ordinance No. 47 which states: "The use of earphone by the driver while driving attached to stereo/radio cassette is strictly prohibited" is hereby amended, so that as amended, the same shall read as follows:

Section 10 - In order to ensure the safety of passengers and to prevent accident involving Trisikads, the installation and use of sound system equipment, radio cassette, stereo and any other musical devices by any Trisikad Driver, is henceforth completely banned.

Section 2 - Violation of this ordinance shall subject the Trisikad Driver to the same penalties provided for in Article 6, Section 8 of City Ordinance No. 47, to wit:

"Violation of Section 5, Article 4, Section 1 and Section 10, Article 5. First offense P100.00 fine and/or imprisonment of ten (10) days; second offense P200.00 fine and/or imprisonment of twenty (20) days; third offense P300.00 fine and/or imprisonment of thirty (30) days at the discretion of the Court and cancellation of License of the driver."

Section 3 - This ordinance shall take effect 10 days after date of publication in a newspaper of general circulation in the city.




