

# TANGGAPAN NG SANGGUNIANG PANLUNGSOD LUNGSOD NG BAKOLOD

CITY ORDINANCE NO. 65 ✓  
Series of 1990

AN ORDINANCE PROHIBITING THE PUBLIC DISPLAY OF PICTURES OR NAMES OF PERSONS SUSPECTED OR CONVICTED OF THEFT OR SHOP LIFTING IN ANY BUSINESS ESTABLISHMENTS OR ANYWHERE WITHIN THE CITY OF BACOLOD.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - Founded upon the principle that the dignity of man is supreme over any proprietary undertaking, it is the declared policy of the Bacolod City Government that public display of names and/or pictures of persons suspected or convicted of theft or shop lifting and like offenses in any business establishments or anywhere within the city is hereby prohibited. This provision, however, does not include the display in the Police Department or in any of its precincts of pictures or names of wanted criminals or those who are at large and subject of a warrant of arrest issued by the Court;

Section 2 - Any person found guilty of violating this Ordinance shall be punished with imprisonment not exceeding six (6) months or a fine not exceeding ONE THOUSAND PESOS (P1,000.00) or both upon the discretion of the Court;

Section 3 - Should this Ordinance be violated by a corporation, partnership, association or firm, the General Manager and/or President and in the absence thereof, any responsible person of said association, business firm, partnership or corporation, shall be held liable to suffer the penalty above-mentioned;

Section 4 - In cases where an association, business firm, partnership or corporation, is found to have violated this Ordinance twice or more, said association, business firm, partnership or corporation, shall, in addition to the penalty above-mentioned, suffer a temporary closure of business for a duration of two (2) days and for this purpose the Office of the Mayor is hereby vested with authority to execute the sanction;

Section 5 - This Ordinance shall be effective immediately fifteen (15) days after its publication in the newspaper of general circulation in the city.

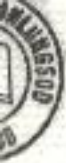


