CITY ORDINANCE NO. 72 ✓  
 January 17, 1991

AN ORDINANCE AMENDING SECTION 5 OF ARTICLE 4, OF CITY ORDINANCE NO. 47, SERIES OF 1988, OTHERWISE KNOWN AS AN ORDINANCE ALLOWING AND REGULATING THE OPERATION OF THE TRI-CYCLE OTHERWISE KNOWN AS "TRISIKAD" PRESCRIBING THE FEES, RULES AND REGULATIONS FOR ITS OPERATIONS.

Be it ordained by the Sangguniang Panlungsod of Bacolod City, in session assembled that:

Section 1. Section 5 of Article 4 of City Ordinance No. 47, Series of 1988, is hereby amended to read as follows:

"Trisikad operators or drivers shall be allowed to charge the following maximum rates:

A. For the first kilometer:

- a. ₱1.50 per passenger;
- b. ₱1.25 per High School or College student passenger;
- c. ₱1.00 per Elementary student passenger.

B. For every kilometer after the first kilometer

- a. ₱0.50 per adult passenger;
- b. ₱0.25 per High School or College student passenger;
- c. ₱0.25 per Elementary student passenger.

Under the preceding paragraph B, students are required to present their Identification Cards and such privilege may be availed of only during school days.

Trisikad operators and drivers shall be required to conspicuously display the authorized rates in their respective units.

For information and guidance, the City Engineer's Office is hereby directed to install the appropriate signs showing the authorized rates in the duly designated Trisikad terminals."

Section 2. This ordinance shall take effect Five (5) days after publication in a local newspaper of general circulation.




