CITY ORDINANCE NO. 73 ✓
 January 24, 1991

AN ORDINANCE PROHIBITING "U" TURNS BY MOTOR VEHICLES IN THE DOWNTOWN AREA, LOPEZ JAENA STREET, AMELIA AVENUE AND PORTIONS OF ARANETA, LACSON, HERNAEZ, GATUSLAO, BURGOS AND SAN JUAN STREETS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

Be it ordained by the Sangguniang Panlungsod of Bacolod in session assembled that:

Section I - For purposes of this ordinance, downtown area shall mean the portion of the City bounded by Lacson Street on the East, Rizal Street on the North, San Juan Street on West and San Sebastian Street on the South.

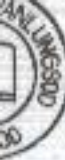
Section II - For execution of "U" Turns are hereby prohibited in the following areas/streets:

- A. Downtown Area
- B. Araneta Street from junction Gonzaga Street up to junction of main exit of the Airport Terminal and from the North approach of Sum-ag Bridge to Crossing Punta Taytay.
- C. Lacson Street from the junction Magsaysay Avenue to junction A. Montelibano, Sr. Boulevard (Circumferential Road).
- D. Lopez Jaena Street from the junction of Hernaez Street to the junction of Sen. Benigno S. Aquino Drive.
- E. Amelia Avenue from the junction Lizares Avenue to junction Hernaez Street.
- F. Gatuslao Street from the junction of Hernaez Street to the junction of the North Capitol Road.
- G. Burgos Street from the junction of San Juan Street to the junction of the Don Alfredo Montelibano, Sr. Boulevard.
- H. San Juan Street from the junction of North Capitol Road to the junction of Rosario Street.

Section III - Violation of this Ordinance shall be punishable as follows:

- A. First Offense - an administrative fine of P50.00 payable within TEN (10) DAYS to the City Treasurer or his duly authorized representative together with the confiscation of license which shall however be returned at once upon full payment of the administrative fine.
- B. Second Offense - an administrative fine of P100.00 payable within TEN (10) DAYS to the City Treasurer or his duly authorized representative together with confiscation of license which shall however be returned upon full payment of the administrative fine.

- C. Third and succeeding Offenses - a fine of not less than P200.00 but not more than P500.00 and/or an imprisonment of not less than TWO (2) DAYS but not more than FIVE (5) DAYS at the discretion of the Court.
- D. In case of failure to comply with the penalties imposed by the provisions of sub-section "A" and/or "B" of this Section, the provision of sub-section "C" shall apply.

Section IV - The City Engineer's Office and the Traffic Division of the INP are hereby tasked to provide the appropriate traffic signs to guide motorists.

Section V - All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby modified and/or repealed accordingly.

Section VI - This ordinance shall take effect after TEN (10) DAYS from the date of publication in a local newspaper of general circulation.


