CITY ORDINANCE NO. 76 ✓
July 4, 1991

AN ORDINANCE AMENDING SECTION 3 OF ARTICLE 6 OF CITY ORDINANCE NO. 47, SERIES OF 1988, OTHERWISE KNOWN AS AN ORDINANCE ALLOWING AND REGULATING THE OPERATION OF THE TRICYCLE OTHERWISE KNOWN AS "TRISIKAD", PRESCRIBING THE FEES, RULES AND REGULATIONS FOR ITS OPERATION.

Be it ordained by the Sangguniang Panlungsod of Bacolod in session assembled, that:

Section 1. Section 3 of Article 6 of City Ordinance No. 47, Series of 1988, is hereby amended to read as follows:

"Section 3. Operating outside of authorized route. No driver shall be allowed to operate a public utility Trisikad outside the route for which it was authorized as indicated in the certificate of registration. For violation of this provision, the driver shall pay a fine of ₱100.00 and/or imprisonment of ten days for the first offense; ₱200.00 fine and/or 20 days imprisonment for the second offense; and ₱300.00 fine and/or imprisonment of 30 days for the third offense at the discretion of the court. If the offenses stated in this Section are committed by said driver within a period of only two (2) months, his license shall be deemed automatically revoked and he can only be issued another license to drive a Trisikad after a period of six (6) months from the date of revocation."

"Section 3-A. If the driver operating outside of authorized route does not have a license, the Trisikad shall immediately be impounded at the nearest police station/substation or headquarters and can be released only upon payment of a fine of ₱100.00 for the first violation; ₱200.00 for the second violation; and ₱300.00 for the third and succeeding violations. This is without prejudice to the provision of Section 7 of this Article."

Section 2. This ordinance shall take effect Ten (10) days after publication in a local newspaper of general circulation.




