CITY ORDINANCE NO. 77
November 21, 1991

AN ORDINANCE AMENDING CITY ORDINANCE NO. 15, SERIES OF 1986.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - City Ordinance No. 15, Series of 1986 entitled "An Ordinance Imposing a Tax on Video Recorders (VTR) Clubs/Operators in the City of Bacolod" is hereby amended to include Laser Disc Video Clubs/Operators, so that as amended, the same shall read as follows:

"AN ORDINANCE IMPOSING A TAX ON VIDEO
TAPE RECORDERS (VTR) AND LASER DISC VIDEO
OPERATORS IN THE CITY OF BACOLOD."

Section 2 - Section 6 of City Ordinance No. 15, Series of 1986 which is the Penalty Clause is likewise amended to read as follows:

"Section 6 - Penalty Clause. Violation of the provisions of this ordinance shall subject the Video Tape Recorders and/or Laser Disc Video Clubs/Operators to a fine of not exceeding TWO HUNDRED PESOS (P200.00) or an imprisonment of not more than six (6) months, or both such fine and imprisonment at the discretion of the Court, without prejudice to the cancellation of the permit to operate."

Section 3 - Repealing Clause. All other ordinances contrary to or inconsistent with the provisions of this ordinance are hereby revoked and/or repealed accordingly.

Section 4 - Effectivity. This ordinance shall take effect Ten (10) days after its publication.


