CITY ORDINANCE NO. 79 
February 27, 1992

AN ORDINANCE CREATING THE HUMAN RESOURCE MANAGEMENT REVIEW BOARD TO RECOMMEND AND REVIEW PERSONNEL MANAGEMENT PLANS AND ACTIONS AIMED TOWARD UPLIFTMENT OF CITY GOVERNMENT EMPLOYEES.

Be it ordained by the Sangguniang Panlungsod of Bacolod City, that:

Section 1: The Human Resource Management Review Board is hereby created to aid the Sangguniang Panlungsod in the formulation of ordinances and resolutions in connection with the exercise of its powers under the provisions of Section 458 of R.A. 7160.

Section 2: Composition: - The Human Resource Management Review Board shall be composed of:

1. A representative of the Sangguniang Panlungsod who will automatically be the Chairman;
2. A representative from the Human Resource Management Office;
3. A representative from the City Budget Office;
4. A representative from the City Treasurer's Office;
5. A representative of the Union accredited by the Civil Service Commission representing the majority of the city employees; and
6. The Head of the Department to which employee/s subject of review belong; and
7. A representative from the Civil Service Commission.

Section 3: - Functions:

1) To review all recommendations and actions made by the Human Resource Management Office with regard to the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly out of city funds and submit findings/recommendations to the Sangguniang Panlungsod;

2) To review all appeals of the officials and employees from any action, determination, decision or order made by the Human Resource Management Office affecting position reclassification and/or upgrading of employees and submit its findings/recommendations to the Sangguniang Panlungsod;

3) To study, evaluate and recommend plans for the upliftment and betterment of the city employees; and

4) To perform such other related duties that may be assigned to it from time to time by the City Mayor or the Sangguniang Panlungsod;

Section 4: The members of the board shall receive such honorarium as may be determined by the Sangguniang Panlungsod.

Section 5: This ordinance shall take effect ten (10) days from publication in a newspaper of general circulation in the City of Bacolod.




