CITY ORDINANCE NO. 91 ✓

June 8, 1993

AN ORDINANCE CREATING AND ESTABLISHING AN EMPLOYMENT MONITORING AND MANPOWER PLACEMENT UNIT UNDER THE OFFICE OF THE BACOLOD CITY DEPARTMENT OF SOCIAL SERVICES AND DEVELOPMENT (DSSD), AND FOR OTHER PURPOSES.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1. Created Unit. An Employment Monitoring and Manpower Placement Unit is hereby created in Bacolod City under the jurisdiction and supervision of the Department of Social Services and Development (DSSD).

Section 2. Functions. The Employment Monitoring and Manpower Placement Unit shall perform the following:

2-A Coordinate with existing local employment agencies or personnel offices and establishments in the City of Bacolod to monitor vacant and available working positions.

2-B Collate all available job vacancies and publish the same on the conspicuous places within the Department.

2-C Accept and process all applications and pertinent requirements for employment from bonafide residents of Bacolod City and sort them according to respective positions desired.

2-D Recommend applicants for employment to vacant positions commensurate to their qualifications.

Section 3. Manpower/Personnel of the Unit. The Employment Monitoring and Placement Unit shall be manned by existing personnel or Social Workers of the DSSD who shall perform the functions stated in paragraph 2 hereof aside from the duties and responsibilities mandated upon them by the City Government of Bacolod.

Section 4. Re-Alignment of Personnel Functions. The Department Head of the Department of Social Services and Development is hereby tasked to re-align the specific functions of all personnel under the said office to effectively pursue the efficient implementation, and conform with the objectives of this new mandate.

Section 5. Effectivity. This ordinance shall take effect upon its approval.






