CITY ORDINANCE NO. 101  
July 29, 1993

ORDINANCE EXTENDING THE EFFECTIVE DATE OF THE TAX RELIEF UNDER CITY ORDINANCE NO. 86.

WHEREAS, under City Ordinance No. 86, Series of 1993, taxpayers of Bacolod City with real estate tax delinquency were given up to July 31, 1993 within which to settle their tax liabilities with a condonation of interests and penalties if the taxes are paid on the period above specified;

WHEREAS, the purpose of the tax relief ordinance is to ease the present economic condition and to encourage tax payments to improve the coffers of the city by virtue of the expected increase in real estate tax revenue collection;

WHEREAS, the report on the availment of the tax relief ordinance by the City Treasurer shows a very discouraging result because only few have availed of the tax relief ordinance due to the adverse financial condition aggravated by the fact that this period being lean month season in Bacolod City and the rest of the province;

WHEREAS, in order to attain the objective of City Ordinance No. 86 and to give allowance and/or extension to the taxpayers who are willing to avail of the city ordinance but are presently unable to do so due to severe financial constraint, it is necessary to extend the efficacy of the ordinance preferably after the lean months on/or December 31, 1993.

WHEREFORE, be it ordained by the Sangguniang Panlungsod of Bacolod City, that:

Section 1 - The tax relief provided for under City Ordinance No. 86 be extended to December 31, 1993 subject to the same conditions therein set forth.

Section 2 - This ordinance shall take effect immediately upon approval.


