CITY ORDINANCE NO. 106
December 7, 1993

AN ORDINANCE AMENDING CITY ORDINANCE NO. 90, SERIES OF 1993, OTHERWISE KNOWN AS AN ORDINANCE PROVIDING FOR THE PREVENTING, CONTROLLING, REGULATING AND ABORTING OF AIR POLLUTION FROM MOTOR VEHICLES FLYING THE CITY STREETS AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

RESOLVED, to amend City Ordinance No. 90, Series of 1993, otherwise known as an "Ordinance providing for the preventing, controlling, regulating and aborting of air pollution form motor vehicles plying the city streets and prescribing penalties for violation thereof, so that as amended the same shall read as follows, to wit:

"Section 6 - Voluntary Testing. - Owner, operator or corporations shall be encouraged to have their motor vehicles for voluntary testing by either requesting for a schedule at the PNP compound or at the garage of the corporation.

Voluntary Emission Test shall be charged Fifty Pesos (P50.00) per vehicle tested.

Vehicles which passed the Emission Test shall be issued a Certificate of Emission Test while vehicles which would not pass shall be impounded at the owner's or corporation's garage until a retest shall have been conducted.

Section 7 - Information. - The Public Information officers under the City Mayor shall see to it that an extensive information campaign on this Ordinance shall be conducted; provide signboards in conspicuous places in the city and from time to time conduct an information seminar to drivers.

Section 8 - Effectivity. - This ordinance shall take effect thirty days (30) after approval.
