CITY ORDINANCE NO. 116
October 6, 1994

OK
AN ORDINANCE MAKING MANDATORY FOR ALL PU'S, GARAGE AND TAXI UNITS
PLYING THE STREETS OF BACOLOD TO BUILD, INSTALL AND CONSTRUCT DRIVER'S
PROTECTIVE COVERING SHELL AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

Be it ordained by the Sangguniang Panlungsod of Bacolod City during
its regular session.

Section 1. Title : This Ordinance shall be known as Bacolod City
Protective Safety Measure for PU's, Garage and Taxi Units Drivers.

Section 2. Definition of Terms

2.A - PUBLIC UTILITY VEHICLES

- Public Carrier or transportation engaged in the
business of transporting passengers/commuters using
the roads of Bacolod City for a fee.

2.B - TAXI

- Public Carrier or transportation which uses meter to
exact payment in conveying or transporting
passengers/commuters in any place in Bacolod City
using her streets and roads.

2.C - PUBLIC UTILITY VEHICLE OPERATOR/OWNER:

Any person natural or juridical which owns and
operate any PU's, Garage and Taxi Units in Bacolod
City.

2.D - PU, GARAGE AND TAXI DRIVER:

Any natural person qualified and licensed to drive
any PU, Garage and Taxi units in Bacolod City.

Section 3. Requirements: All operators, owners, and drivers of all
PU's, Garage and Taxi Units operating and plying in the streets of
Bacolod City shall install, provide, construct and build Driver's
Protective Covering Shell on every unit of vehicles owned, operated and
driven as a means of securing, protecting and insuring safety of the
driver in the course of their performance of a day to day activities.

Section 4 . Make and Type: That this Driver's Protective Covering
Shell be made of steel bars, welded wire and bolts described in the
herein Sketch as Annex "A" hereof.

Section 5 . Penalties - That any owner, operator and/or driver who
fails to install, construct and build the driver's Protective and
Covering Shell upon conviction shall be imprisoned for a period of not
exceeding 6 months inclusive of a fine of not less than P1,000.00 or both
such fine and imprisonment as may be directed by the Honorable Court.

Section 6 . Effectivity - This Ordinance shall take effect within three (3) calendar months from approval thereof.


