AN ORDINANCE CHARGING THE CAVALOP PRODUCTIONS A FIVE PERCENT (5%) AMUSEMENT TAX ON THE CONCERT ENTITLED "ANG TV... LIVE SA BACOLOD" TO BE HELD ON DECEMBER 10, 1994 AT THE COLEGIO DE SAN AGUSTIN-BACOLOD, THE BENEFICIARY OF WHICH IS THE BACOLOD BOYS HOME AS CONTAINED IN THE LETTER-REQUEST OF BENJAMIN L. TORRE, CREATIVE DIRECTOR, CAVALOP PRODUCTIONS, DATED NOVEMBER 7, 1994 DOCKETED AS SP CORRESPONDENCE NO. 94-1309.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The Cavalop Productions is hereby charged a five percent (5%) amusement tax on the concert entitled "Ang TV... Live sa Bacolod" to be held on December 10, 1994 at the Colegio de San Agustin-Bacolod, the beneficiary of which is the Bacolod Boys Home as contained in the letter request of Benjamin L. Torre, Creative Director, Cavalop Productions, dated November 7, 1994 docketed as SP Correspondence No. 94-1309.

Section 2 - This ordinance shall take effect upon approval.
