CITY ORDINANCE NO. 121
 December 1, 1994

AN ORDINANCE AMENDING CITY ORDINANCE NO. 103, SERIES OF 1993, WHICH READS: "AN ORDINANCE ENACTING THE SCHEDULE OF FAIR MARKET VALUE FOR THE DIFFERENT CLASSES OF REAL PROPERTY IN BACOLOD CITY AS THE BASIS FOR APPRAISAL AND ASSESSMENT OF REAL PROPERTY PURSUANT TO SECTION 212 OF REPUBLIC ACT 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991."

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - City Ordinance No. 103, series of 1993, which reads: "An ordinance enacting the schedule of Fair Market Value for the different classes of Real Property in Bacolod City as the basis for appraisal and assessment of real property pursuant to Section 212 of Republic Act 7160 otherwise known as the Local Government Code of 1991," is hereby amended to read as follows, to wit:

"An Ordinance approving the schedule of Fair Market Value of the City of Bacolod as well as the assessment levels of land and building, commercial, residential and industrial buildings in the City of Bacolod."

Section 2 - Repealing Clause - All ordinances inconsistent with this ordinance ~~are~~ deemed repealed.

Section 3 - Effectivity - This Ordinance shall take effect January 1, 1995.
