AN ORDINANCE GRANTING EXEMPTION FROM THE PAYMENT OF AMUSEMENT TAX THE BASKETBALL EXHIBITION GAME FEATURING THE PBA TEAMS OF ALASKA MILK KINGS AND SWIFT MIGHTY MEATIES SPONSORED BY THE UNIVERSITY OF ST. LA SALLE TO BE HELD ON FEBRUARY 12, 1995 AT THE UNIVERSITY OF ST. LA SALLE COLISEUM, THIS CITY, PER LETTER REQUEST OF BRO. ROLANDO DIZON, FSC, PRESIDENT, UNIVERSITY OF ST. LA SALLE, DATED JANUARY 27, 1995, DOCKETED AS SP CORRESPONDENCE NO. 95-142.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The Basketball Exhibition Game featuring the PBA Teams of Alaska Milk Kings and Swift Mighty Meaties sponsored by the University of St. La Salle, to be held on February 12, 1994 at the University of St. La Salle Coliseum, this city, is hereby granted an exemption from the payment of amusement tax per letter of Bro. Rolando Dizon, FSC, President, University of St. La Salle, dated January 27, 1995, docketed as SP Correspondence No. 95-142.
