CITY ORDINANCE NO. 134  
June 15, 1995

AN ACT TO REPEAL CITY ORDINANCE NO. 116, SERIES OF 1994, OTHERWISE KNOWN AS "AN ACT MAKING MANDATORY FOR ALL PUJ'S, GARAGE AND TAXI UNITS PLYING THE STREETS OF BACOLOD TO BUILD, INSTALL AND CONSTRUCT DRIVER'S PROTECTIVE COVERING SHELL AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF."

WHEREAS, the effectiveness of C.O. 116 otherwise known as "An Act making mandatory for all PUJ'S, Garage and Taxi units plying the streets of Bacolod to build, install and construct Driver's Protective Covering Shell and providing penalties for violations thereof," is no longer the felt need of all those concerned.

WHEREAS, the end result of consultation and dialogue with the drivers and operators of Taxis, Garage, PUJ's, etc. was that the City Ordinance No. 116 will work to their prejudice and would expose their limb and life more to danger and hazard.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

SECTION 1- That City Ordinance No. 116 in its entirety is hereby considered repealed, withdrawn and of no more force and effect.

Section 2 - That this repealing act shall at once become effective upon its approval.


