CITY ORDINANCE NO. 135

June 15, 1995

AN ORDINANCE EXEMPTING FROM THE PAYMENT OF AMUSEMENT TAX THE CONCERT SPONSORED BY ASCEND, INCORPORATED TO BE HELD ON JUNE 30, 1995 AT THE ST. LA SALLE COLISEUM, THE PROCEEDS OF WHICH WILL GO TO THE WOMEN YOUTH CHILDREN OUTREACH FOUNDATION (WYCO) AND OTHER OUTREACH PROGRAMS OF USLS AS CONTAINED IN THE LETTER OF VICTOR M. ANGUDONG, MANAGING EDITOR, ASCEND, INCORPORATED, DATED JUNE 7, 1995 AND DOCKETED AS SP CORRESPONDENCE NO. 95-725.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The concert sponsored by ASCEND, INCORPORATED which will be held on June 30, 1995 at the La Salle Coliseum is hereby exempted from the payment of amusement tax, the proceeds of which will go to the Women Youth Children Outreach Foundation (WYCO) and other outreach programs of USLS as contained in the letter of Victor M. Angudong, Managing Editor, Ascend, Incorporated, dated June 7, 1995 and docketed as SP Correspondence No. 95-725.

Section 2 - This ordinance shall take effect immediately upon approval.




