CITY ORDINANCE NO. 138
June 22, 1995

AN ORDINANCE WIDENING A PORTION OF RIZAL STREET ALONG THE ENTRANCE OF THE RECLAMATION AREA.

Be it ordained by the Sangguniang Panlungsod of Bacoled, that:

WHEREAS, the width of the road along Rizal Street fronting the San Sebastian Cathedral is 25 meters in width;

WHEREAS, the road leading to the entrance of the Reclamation Area which is a part of Rizal Street is presently measured at 16 meters in width;

WHEREAS, there is a need to widen the portion of Rizal Street along the entrance of the Reclamation Area from 16 to 25 meters in width in order that it will be accessible to a greater number of vehicles plying that road especially when it comes to traffic rerouting.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to pass an Ordinance to wit:

Section 1 - That it is necessary to widen a portion of Rizal Street along the entrance of the Reclamation Area to make it accessible to a greater number of vehicles plying that road.

Section 2 - That the portion of Rizal Street at the entrance of the Reclamation Area be widen from 16 to 25 meters in width.

Section 3- That an amount of SIX HUNDRED THOUSAND PESOS (P600,000.00) shall be appropriated for this purpose.

Section 4 - This ordinance shall take effect upon its approval.
