AN ORDINANCE CHARGING A 10% AMUSEMENT TAX ON A CONCERT ENTITLED "BEYOND COMPARE WITH VERNIE VARGA" TO BE HELD ON OCTOBER 14, 1995 AT THE ISLAND BALLROOM OF THE BACOLOD CONVENTION PLAZA HOTEL WHICH CONCERT WILL BE FOR THE BENEFIT OF HOPE FOUNDATION, INC. AS CONTAINED IN THE LETTER-REQUEST OF NICK V. LIZARES, PROJECT DIRECTOR, DATED SEPTEMBER 25, 1995, DOCKETED AS SP CORRESPONDENCE NO. 95-1399.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - A 10% Amusement Tax is hereby charged on a concert entitled: "Beyond Compare with Vernie Varga" to be held on October 14, 1995 at the Island Ballroom of the Bacolod Convention Plaza Hotel which concert will be for the benefit of Hope Foundation, Inc. as contained in the letter-request of Nick V. Lizares, Project Director dated September 25, 1995, docketed as SP Correspondence No. 95-1399.

Section 2 - This Ordinance shall take effect upon its approval.


