CITY ORDINANCE NO. 151

AN ORDINANCE CHARGING MR. DAVIN T. SABRINE A TEN (10%) PERCENT AMUSEMENT TAX IN CONNECTION WITH THE AIZA SEGUERRA SHOW TO BE HELD ON DECEMBER 17, 1995 AT THE BAYS CENTER, THE BENEFICIARY OF WHICH IS THE HOLY INFANT ORPHANAGE AT SUM-AG, BACOLOD CITY, AS CONTAINED IN HIS LETTER DATED NOVEMBER 30, 1995, DOCKETED AS SP CORRESPONDENCE NO. 95-1895.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - A ten (10%) percent amusement tax is hereby charged to Mr. Davin T. Sabrine in connection with the Aiza Seguerria Show to be held on December 17, 1995 at the BAYS Center, the beneficiary of which is the Holy Infant Orphanage at Sum-ag, Bacolod City, as contained in his letter dated November 30, 1995, docketed as SP Correspondence No. 95-1895.

Section 2 - That out of the ten (10%) percent amusement tax, five (5%) percent will go to the Holy Infant Orphanage and the other five (5%) percent to the City of Bacolod.

Section 3 - This ordinance shall take effect upon its approval.






