CITY ORDINANCE NO. 152

AN ORDINANCE EXEMPTING FROM THE PAYMENT OF AMUSEMENT TAX THE VICE MAYORS LEAGUE OF THE PHILIPPINES, NEGROS OCCIDENTAL CHAPTER, IN CONNECTION WITH THE HOLDING OF A 4-COCK DERBY ON JANUARY 5 AND 6, 1996 AT THE DON CARLOS J.A. MONTILLA MEMORIAL STADIUM, THE PROCEEDS OF WHICH WILL FINANCE THE DIFFERENT PROJECTS OF THE LEAGUE, PER LETTER-REQUEST OF VICE MAYOR FORTUNATO S. JAVELONA, CHAIRMAN, DERBY COMMITTEE, DATED DECEMBER 13, 1995, DOCKETED AS SP CORRESPONDENCE NO. 95-1990.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The Vice Mayors League of the Philippines, Negros Occidental Chapter, is hereby exempted from the payment of amusement tax in connection with the holding of a 4-cock derby on January 5 and 6, 1996 at the Don Carlos J.A. Montilla Memorial Stadium, the proceeds of which will finance the different projects of the league, per letter-request of Vice Mayor Fortunato S. Javelona, Chairman, Derby Committee, dated December 13, 1995, docketed as SP Correspondence No. 95-1990.


Section 2 - This ordinance shall take effect upon its approval.
