CITY ORDINANCE NO. 169  
June 27, 1996

AN ORDINANCE CREATING THE CLEAN AND GREEN PROJECT  
COMMITTEE UNDER THE OFFICE OF THE CITY MAYOR.

WHEREAS, there is now a regular annual contest mandated by the National Government to select the cleanest and greenest cities and municipalities in the entire countries and also to select the dirtiest local government units;

WHEREAS, Bacolod City has consistently been chosen top ten (10) among the cleanest and greenest highly urbanized cities in the country wherein it garnered 5th in 1994 and 3rd in 1995;

WHEREAS, to maintain the momentum and to improve the standing of Bacolod City, it is imperative that a permanent committee known as a *CLEAN AND GREEN COMMITTEE* be created under the Office of the Mayor to pursue the continuing program of the clean and green project.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - A Clean and Green Project Committee is hereby created under the Office of the City Mayor composed of the Chairman to be chosen by the Mayor, preferably City DILG Officer, the representative of the City Mayor, Sangguniang Panlungsod Member and such other personnel designated by the City Mayor to hereby continually supervise devise ways and means and make plan for the implementation of the Clean and Green Program.

Section 2 - An amount of ONE MILLION PESOS (P1,000,000.00) shall be appropriated annually to be taken from whatever available fund under the Office of the City Mayor.

Section 3 - The Committee is empowered to promulgate rules and regulations to implement this project.

Section 4 - This Ordinance shall take effect upon its approval.


