

CITY ORDINANCE NO. 177

June 26, 1997

AN ORDINANCE PROHIBITING ALL PUSH CARTS, MOTORCYCLES, BICYCLES AND TRISIKADS AND OTHER DELIVERY CARTS EXCEPT DELIVERY CARTS WITH RUBBER EXTERIOR IN ALL PUBLIC MARKETS.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section I: Statement of Purpose

It is the purpose of the City Government of Bacolod thru this ordinance to protect, preserve and decongest all public markets within the city in order to provide a healthful and convenient environment within the premises of all public markets.

Section II: Definition of Terms

- a) Public Markets - the term shall refer to the Central Market, Burgos Market, Libertad Market, Sum-ag Public Market, Granada Public Market and other like markets that maybe hereafter be constructed by the National, City or Barangay Government;
- b) Push Carts - shall refer to unmotored wheeled vehicles which are moved by the application of human force;
- c) Motorcycles - shall refer to motored vehicles which are used to transport a person or thing;
- d) Bicycles - shall refer to the two-wheeled unmotored vehicles which move by the application of a pedaled force;
- e) Trisikads - shall refer to the three-wheeled unmotored vehicles as defined in the trisikad ordinance;
- f) Delivery Cart - this term shall refer to any wheeled vehicles which is used to transport, carry, transfer or deliver a person(s) or thing.

Section III: Prohibition

All push carts, motorcycles, bicycles and other delivery carts except delivery carts with two (2) wheels and with rubber exteriors are prohibited in all Public Markets.

Section IV: Penalty

Any person caught violating Section III hereof shall be penalized as follows:

1. First Offense - Administrative fine of P1,000.00.
2. Second Offense - Administrative fine of P1,000.00 and imprisonment of not less than 15 days but not more than 30 days or fine of P1,000.00 or both at the discretion of the court.

Section V: Effectivity Clause

This Ordinance shall take effect thirty (30) days after its publication for three (3) consecutive days in a newspaper of general circulation.


