CITY ORDINANCE NO. 178

September 4, 1997

AN ORDINANCE NAMING THE UNNAMED STREET BETWEEN JOLLIBEE-LA SALLE AVENUE AND MC METROPLEX BUILDING-B.S. AQUINO DRIVE, "DR. LEONARDO F. GALLARDO STREET".

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

WHEREAS, Dr. Leonardo F. Gallardo has set an exemplary record of achievements and selfless service worthy of emulation;

WHEREAS, Dr. Leonardo G. Gallardo was a Battalion Surgeon and a Commanding Officer of the 31st Station Hospital of the Philippine Army, and was awarded a Bronze Star Medal and a Military Merit Medal for services in the USAFE in World War II;

WHEREAS, Dr. Leonardo F. Gallardo had served Doctor's Hospital, Bacolod City as Medical Director, and was a fellow of the Philippine College of Surgeons;

WHEREAS, Dr. Leonardo F. Gallardo is a past president and past District Governor of the Rotary Club, and is likewise the Father of the Rotex Program;

WHEREAS, Dr. Leonardo F. Gallardo was awarded the Colombo Plan Special Visitor to Australia;

WHEREAS, it is but proper to honor Dr. Leonardo F. Gallardo by naming the unnamed street between Jollibee-La Salle Ave. and Mc Metroplex Building-B.S. Aquino Drive, "Dr. Leonardo G. Gallardo Street."

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to pass this ordinance:

Section 1 - The unnamed street between Jollibee-La Salle Avenue and Metroplex Building-B.S. Aquino Drive shall be named "Dr. Leonardo F. Gallardo Street."

Section 2 - Effectivity. This ordinance shall take effect fifteen (15) days after approval.




