CITY ORDINANCE NO. 179  
September 11, 1997

AN ORDINANCE AMENDING CHAPTER III OF CITY ORDINANCE NO. 160, SERIES OF 1996, KNOWN AS THE MARKET CODE OF BACOLOD CITY BY ADDING SECTION 12-B WHICH FIXES THE MARKET RENTAL FEES AND OTHER FEES FOR THE OCCUPANTS OF THE LIBERTAD MARKET TWO-STORY ANNEX BUILDING.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

**Section 1** - Chapter III of City Ordinance No. 160, series of 1996, known as the Market Code of Bacolod City, is hereby amended by adding Section 12-B which fixes the market rental fees and other fees for the occupants of the Libertad Two-Storey Annex Building which reads as follows, to wit:

Section 12-B. Market rental fees for vendors occupying the Libertad Market Two-Storey Annex Building are hereby fixed as follows:

<u>Area</u>	<u>Rental Per Day</u>
Second Floor	P 5.00
First Floor	10.00

**Section 2** - All occupants of the Libertad Market Two-Storey Annex Building shall likewise pay all fees found in this ordinance. However, the occupancy fees shall be paid on a staggered basis of four equal quarterly installments.

**Section 3** - This ordinance shall take effect immediately upon its approval.


