CITY ORDINANCE NO. 180

September 11, 1997

AN ORDINANCE AMENDING ARTICLE VIII, CHAPTER II, OF TAX ORDINANCE NO. 93-001, SERIES OF 1993, AS AMENDED BY CITY ORDINANCE NO. 154, SERIES OF 1995", DOCKETED AS SP CORRESPONDENCE NO. 97-1278.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - Article VIII, Chapter II of Tax Ordinance No. 93-001, series of 1993, as amended by City Ordinance No. 154, Series of 1995 is hereby amended to read as follows, to wit:

CHAPTER II - CITY TAXES

ARTICLE VIII - TAX ON BUSINESS

Section 24. Imposition of Tax. There is hereby levied an annual tax on the business...

h-9. On fish and vegetable vendors on all stalls in the public markets at the rate of TWO HUNDRED FORTY SEVEN & 50/100 (P247.50) PESOS per annum to be collected on the preceding year's gross sales or receipts of TWENTY THOUSAND (P20,000.00) PESOS to THIRTY THOUSAND (P30,000.00) PESOS, maximum amount of business tax to be imposed on such vendors of commodities.

Section 2 - This ordinance shall take effect on October 1, 1997.


