CITY ORDINANCE NO. 181  
Series of 1997

AN ORDINANCE CREATING/CLASSIFYING VARIOUS POSITIONS IN THE OFFICE OF THE CITY ACCOUNTANT AND APPROPRIATING FUNDS THEREOF.

WHEREAS, with the passage of the Local Government Code of 1991, the Office of the City Accountant is one of the mandatory department of the Local Government Unit;

WHEREAS, in the implementation of the Local Government Code the merging of the two (2) existing offices, the Accounting and Internal Control was affected, however, no organizational change have been instituted to cope up with the expanded scope of responsibilities and the need to restructure the organization;

WHEREAS, the Office of the City Accountant as a mandatory Department is tasked with a vital function of accounting and internal auditing services thus the need for the creation/reclassification of various positions.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The following positions are hereby created/reclassified for the Office of the City Accountant and appropriating the amount of ONE HUNDRED EIGHTY FIVE THOUSAND FOUR HUNDRED SEVENTEEN PESOS AND FORTY CENTAVOS (P185,417.40) to be taken from the salary savings of the said office, per certification of the City Treasurer dated, July 9, 1997, docketed as SP Correspondence No. 97-787-A, to wit:




