CITY ORDINANCE NO. 183
Series of 1997

"AN ORDINANCE REPEALING ORDINANCE NO. 156, SERIES OF 1980.

WHEREAS, Ordinance No. 156, Series of 1980 allows the use of one-half of Mercedes Avenue as part of the Libertad or South Public Market and the construction of vending shedhouses thereon;

WHEREAS, such Ordinance effectively narrows and congests the traffic flow along said avenue;

WHEREAS, awardees who have not violated any provision of the Market Code will be relocated at the new two-storey building at Amelia Street;

WHEREAS, such relocation of vendors and demolition of shedhouses occupied by them at Mercedes Avenue will restore Mercedes Avenue to its original width;

WHEREAS, restoring Mercedes Avenue to its original width will redound to the benefit of the general public;

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - This Ordinance shall be titled "*An Ordinance Repealing Ordinance No. 156, Series of 1980*".

Section 2 - Upon the completion and readiness for occupancy of the two-storey Libertad Annex-Building, original awardees who have not violated any provisions of the Market Code shall be relocated and awarded stalls at the new two-storey building.

Section 3 - After the relocation and award, all structures and shedhouses on Mercedes Avenue shall be demolished by City Engineer's Office. Mercedes Avenue shall thereafter be utilized solely as a public street.

Section 4 - All ordinances contrary to and inconsistent with this ordinance are hereby repealed.

Section 5 - This Ordinance shall take effect upon approval.


