

CITY ORDINANCE NO. 188

November 13, 1997

AN ORDINANCE APPROVING THE CHANGING OF THE NOMENCLATURE IN THE PLANTILLA OF PERSONNEL OF THE LICENSE DIVISION, CITY TREASURER'S OFFICE, ITEM NOS. 3 TO 8, FROM LOCAL TREASURY EXAMINER, GRADE 15 TO LOCAL TREASURY OPERATIONS OFFICER II, GRADE 15, PER LETTER-REQUEST OF MRS. 


