CITY ORDINANCE NO. 194 Series of 1997

AN ORDINANCE NAMING 21TH STREET AS "TAGAYTAY STREET" IN HONOR OF TAGAYTAY CITY.

WHEREAS, on March 6, 1997, the Sangguniang Panlungsod of Bacolod passed Resolution No. 250-B approving the Sister City Relationship with the City of Tagaytay;
