AN ORDINANCE AMENDING THE SCHEDULE OF FEES AND CHARGES FOR ANTE-MORTEM AND POST MORTEM INSPECTION SERVICES FOR POULTRY ITEMS AS PROVIDED FOR IN ORDINANCE NO. 1, SERIES OF 1974.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - That the schedule of fees and charges for Ante-mortem and Post-mortem inspection for poultry items as provided for in Ordinance No. 1, Series of 1974 is hereby amended for purposes of collecting ante-mortem and post-mortem inspection services rendered by the office of the City Veterinarian, to wit:

- a) Ante-mortem Inspection Fee:  
for the inspection of poultry prior to slaughter/dressing to determine presence of disease/abnormal condition .....P0.15/head
- b) Post-mortem Inspection Fee:  
for the inspection of the carcasses and the edible offals or poultry slaughtered/dressed to detect the presence of lesions and abnormalities .....P0.25/kilogram

Section 2. Effectivity. This ordinance shall take effect FIFTEEN (15) days after its publication in a newspaper of general circulation in the City of Bacolod.




