CITY ORDINANCE NO. 201  
January 15, 1998

AN ORDINANCE AMENDING CITY ORDINANCE NO. 190, SERIES OF 1997, TO READ AS "AN ORDINANCE NAMING 24TH STREET AS 'CAGAYAN DE ORO CITY STREET' IN HONOR OF CAGAYAN DE ORO CITY".

WHEREAS, on January 30, 1997, the Sangguniang Panlungsod of Bacolod passed Resolution No. 117 proposing a Sister City Relation with Cagayan de Oro City;

WHEREAS, on November 4, 1997, the Sister City Friendship Affiliation between the Cities of Bacolod and Cagayan de Oro officially commenced and the Protocol Sister City Agreement was likewise ratified and signed by Vice Mayor Wilmar L. Drilon, representing Bacolod and Mayor Pablo B. Magtajas, representing Cagayan de Oro;

WHEREAS, on the conditions stipulated in the said Protocol Sister City Agreement states, "The City of Bacolod shall name a street in Bacolod after Cagayan de Oro City and Cagayan de Oro City shall name a street after Bacolod City in Cagayan de Oro".

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - City Ordinance No. 190, series of 1997, is hereby amended to read as follows, to wit:

"AN ORDINANCE NAMING 24TH STREET AS "CAGAYAN DE ORO CITY STREET" IN HONOR OF CAGAYAN DE ORO CITY".

Section 2 - This ordinance shall take effect immediately upon its approval.






