CITY ORDINANCE NO. 206

January 22, 1998

AN ORDINANCE DIRECTING THE BACOLOD CITY TREASURER TO ACCEPT PAYMENT FOR BUSINESS PERMIT OF FISH AND VEGETABLE VENDORS FOR THE YEAR 1998 PENDING CLARIFICATION ON THE QUERY SUBMITTED TO THE DEPARTMENT OF FINANCE RELATIVE TO A PROPOSED ORDINANCE CONDONING THE PAYMENT OF BUSINESS PERMIT OF FISH AND VEGETABLE VENDORS OF BACOLOD CITY PUBLIC MARKETS FROM 1992 TO 1997.

WHEREAS, there is an existing Proposed Ordinance entitled "An ordinance condoning the payment of business permit of fish and vegetable vendors of Bacolod City Public Markets from 1992 to 1997";

WHEREAS, the legality or appropriateness of the said ordinance was questioned and for purposes of clarification the same was indorsed to the Department of Finance, Metro Manila;

WHEREAS, to date no such answer to said query had been received by the Sangguniang Panlungsod;

WHEREAS, the payment of business permit for the year 1998 is about to begin on the month of January 1998 and as such there is a probability that the City Treasurer may not accept said payment unless and until all arrearages are paid in full.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The City Treasurer of Bacolod is hereby directed to accept the payment of business fees and permits for current year 1998 from the fish and vegetable vendors of the Bacolod Public Markets pending clarification by the Department of Finance on the query submitted to the said office relative to a Proposed ordinance condoning the payment of business permit of fish and vegetable vendors of Bacolod Public Markets from 1992 to 1997.


Section 2 - This ordinance shall take effect immediately upon approval.
