CITY ORDINANCE NO. 214
Series of 1998

AN ORDINANCE AMENDING CHAPTER XVI OF CITY ORDINANCE NO. 110, SERIES OF 1956, "AN ORDINANCE REVISING AND COMPILING THE TRAFFIC RULES AND REGULATIONS OF THE CITY OF BACOLOD BY ADDING/INSERTING SECTION 3, PRINTING AND ISSUANCE OF TRAFFIC CITATION TICKET (TCT)".

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - Chapter XVI of City Ordinance No. 110, Series of 1956, "AN ORDINANCE REVISING AND COMPILING THE TRAFFIC RULES AND REGULATIONS OF THE CITY OF BACOLOD" is hereby amended by adding/inserting Section 3 thereof, to wit:

"Section 3. **Printing and issuance of Traffic Citation Ticket (TCT).** - In order to effectively enforce all the traffic rules and regulations in the City of Bacolod and instill discipline on recalcitrant drivers, the City Government through the office of the Mayor shall print or cause the printing of Traffic Citation Ticket (TCT) for the sole use of the members of the Traffic Division of the Bacolod City Police Office including their deputies only.

a) The Traffic Citation Ticket which will be printed in pad/booklet form shall be composed of four (4) pages of different colors bearing the same serial number per set. The original copy shall be remitted by the apprehending officer to the traffic investigator to be used as evidence in the filing of appropriate charges; the second copy or duplicate shall go to the driver cited for committing a traffic violation; the third copy shall go to the Office of the Traffic Division for record and monitoring purposes; and the fourth copy should be retained in the booklet or pad for remittance to the City Treasurer.

b) For proper control and good management and to avoid opportunity for graft and corruption, the TCT shall be treated as an accountable form and should be issued/released directly to the Chief Traffic or his duly authorized representative who shall be responsible in the proper accounting of this form and shall institute necessary measure to safeguard the sanctity of the TCT. It shall be the responsibility of the Chief Traffic to conduct a monthly inventory of all issued TCT to see to it that at least the three copies starting from the 2nd to the 4th copy having the same serial number shall be properly accounted and audited prior to submission to the City Treasurer's Office.

c) The Traffic Citation Ticket shall be used only for violation of city ordinance and shall not

be applicable to violations provided for in R.A. 4136. Drivers apprehended for certain violations shall only be requested to present his/her drivers license for purposes of getting the license number and other data but shall not be subjected for confiscation.

d) All fines and penalties as a result of the violation cited in the TCT shall be paid directly to the Office of the City Treasurer which will form part of the general funds."

Section 2 - This ordinance shall take effect immediately upon approval.
