CITY ORDINANCE NO. 218
Series of 1998

AN ORDINANCE NAMING THE UNNAMED STREET IN FRONT OF FAR EAST BANK, LIBERTAD BRANCH, WHICH CONNECTS HERNAEZ AND LOPEZ-JAENA STREETS AS "NAPOLEON D. GONZAGA STREET".

WHEREAS, the late Napoleon D. Gonzaga had served Bacolod City with utmost dedication as an Elected City Councilor from 1960 to 1963, as an Appointed City Councilor in 1967 and 1970-71, and as an OIC Acting Mayor from December 1987 to February 1988;

WHEREAS, the late Napoleon D. Gonzaga was also an active leader in community service having been a Past President of the Bacolod Jaycees, National Director for Western Visayas of the Philippine Jaycees, Area Vice President for Visayas of the Philippine Jaycees Senate, Past President and Chairman of the Scholarship and Youth Development Foundation, Director of the Philippine National Red Cross, and member of the Executive Board, Negros Occidental Council of the Boy Scouts of the Philippines;

WHEREAS, Napoleon D. Gonzaga's further affiliation with religious organizations, having been a past Rector of the Cursillo and President of the Diocesan Secretariat - Cursillos in Christianity, only manifests his indomitable desire to serve not only his fellow Bacoleños, but God as well;

WHEREAS, it is but fitting and proper to honor the late Napoleon D. Gonzaga by naming a street after his name.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The unnamed street in front of Far East Bank-Libertad Branch, which connects Hernaez and Lopez Jaena Streets shall be named "Napoleon D. Gonzaga Street".

Section 2 - This Ordinance shall take effect upon approval.




