CITY ORDINANCE NO. 221
Series of 1998

AN ORDINANCE NAMING THE NEW STREET FROM THE NEWLY CONSTRUCTED BRIDGE LINKING BARANGAYS 35 AND SINGCANG-AIRPORT UNTIL THE JUNCTION OF MAGSAYSAY AVENUE AS "HON. RICARDO 'REX' J. ARNALDO AVENUE".

WHEREAS, Ricardo "Rex" Arnaldo had been with the Sangguniang Panlungsod of the City of Bacolod as an elected SP Member from 1960 until 1963, and as an appointed SP Member from 1986 until 1987, as such, he had served the people of Bacolod with utmost sincerity and dedication;

WHEREAS, he had been very active in representing the cause of workers, having been former President of the Defunct Allied Workers Association- Bacolod-Murcia Chapter, delegate to the First Labor Seminar of the Labor Education Center of the University of the Philippines and delegate to the Trade Union College of the International Confederation of the Free Trade Union in Calcutta, India;

WHEREAS, he generously donated to the city government his parcel of land where the newly paved street and newly constructed bridge linking Barangays 35 and Singcang-Airport until the junction of Magsaysay Avenue are located;

WHEREAS, it is but fitting and proper to honor him by naming the new street, from the newly constructed bridge linking Barangays 35 and Singcang-Airport until the junction of Magsaysay Avenue, as "Hon. Ricardo 'Rex' J. Arnaldo Avenue".

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Bacolod in session assembled, that:

Section 1. The new street, from the newly constructed bridge linking Barangays 35 and Singcang-airport until the junction of Magsaysay Avenue, shall be named as "Hon. Ricardo 'Rex' J. Arnaldo Avenue."

Section 2.- This ordinance shall take effect upon its approval.
