CITY ORDINANCE NO. 226
Series of 1999

AN ORDINANCE CREATING THE POSITION OF LOCAL LEGISLATIVE EMPLOYEE II, GRADE IV/STEP 1, IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD OF BACOLOD CITY.

WHEREAS, existing structure in the Sangguniang Panlungsod, each Councilor and Vice Mayor are three (3) Technical Staff/Assistants as casual employees directly under his/her command, each casual employee receiving TWO HUNDRED PESOS (P200.00) per day or Four Thousand Four Hundred Pesos (P4,400.00) per month;

WHEREAS, LOCAL BUDGET CIRCULAR NO. 61, SERIES OF 1996 (REVISED INDEXED OF OCCUPATIONAL SERVICES, POSITION TITLES AND SALARY GRADE (IOS) in the local government) issued by the Department of Budget and management casual employees whose tasks and function are confidential in nature, such as the Technical Staff of Councilors and Vice-Mayor in the Sangguniang Panlungsod mandates the creation of position of "Local Legislative Employee II- Grade IV/Step 1 in the Office of the Sangguniang Panlungsod;

WHEREAS, said positions are confidential in nature and are co-terminus with the Councilors and Vice Mayor concerned.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - There is hereby created FORTY-FIVE (45) positions of Local Legislative Employee II, Grade IV/Step 1 in the Office of the Sangguniang Panlungsod.

Section 2 - This ordinance shall take effect immediately upon its approval.
