AN ORDINANCE RECLASSIFYING ONE POSITION OF COLLEGE INSTRUCTOR I (GRADE 12) TO ADMINISTRATIVE OFFICER I (GRADE II) AT THE BACOLOD CITY COLLEGE.

WHEREAS, there are at present four (4) positions of College Instructors at the Bacolod City College which remained unfilled;

WHEREAS, as an educational institution, it is imperative that curricular program, student and faculty development program and physical facilities program be given full attention by the College Administrator;

WHEREAS, there is a felt need to create one (1) position of Administrative Officer I, to take charge of the multifarious needs of the office like managing the office, preparing reports, keeping records, preparing vouchers, and supervising the staff: Now, therefore be it resolved as it is hereby resolved to reclassify One (1) position of College Instructor I (Grade 12) to Administrative Officer I (Grade 11) in the plantilla of personnel at the Bacolod City College.

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Bacolod, that:

SECTION 1 - Reclassifying One (1) position of College Instructor I (Grade 12) in 1999 plantilla of personnel, Bacolod City College to Administrative Officer I (Grade 11).

SECTION 2 - This Ordinance shall take effect fifteen (15) days after its approval.
