AN ORDINANCE APPROVING THE INCREASE OF THE CURRENT SALARY GRADE OF MS. LYDIA H. ARROYO, HEALTH EDUCATION AND PROMOTION OFFICER III, CITY HEALTH OFFICE, TO ONE (1) GRADE HIGHER, FROM GRADE 18/S-7 TO GRADE 19/S-7 PURSUANT TO RULE VIII, SECTION 2 OF R.A. 7305 WHICH IS THE MAGNA CARTA FOR PUBLIC HEALTH WORKERS, PER 2ND INDORSEMENT OF THE CITY BUDGET OFFICER, MANFREDO E. MONTAÑO, DATED MARCH 11, 1999, DOCKETED AS SP CORRESPONDENCE NO. 99-795.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

**Section 1** - The latest salary grade of Ms. Lydia H. Arroyo, Health Education and Promotion Officer III, City Health Office, is hereby increased to one (1) grade higher, from Grade 18/S-7 to Grade 19/S-7 pursuant to Rule VIII, Section 2 of R.A. 7305 which is the Magna Carta for Public Health Workers, to wit:

**Section 2.** "Highest Basic Salary upon retirement. Three (3) months before compulsory retirement, the public health worker shall be granted on automatic one (1) grade salary increase in his basic salary and his retirement benefit thereafter shall be completed on the basis of his highest salary received and paid. Provided that the public health worker has reached retirement age and fulfilled the service requirements under the existing law".




