



CITY ORDINANCE NO. 239

September 23, 1999

AN ORDINANCE APPROVING THE REQUEST OF PATRIA P. GENSOLI, MD, MPA, CITY HEALTH OFFICER OF THE CITY HEALTH DEPARTMENT, TO INCREASE HER LATEST SALARY TO ONE (1) GRADE HIGHER PRIOR TO HER COMPULSORY RETIREMENT IN PURSUANCE TO SECTION 2, RULE VIII OF REPUBLIC ACT 7305 OTHERWISE KNOWN AS THE MAGNA CARTA FOR PUBLIC HEALTH WORKERS, DOCKETED AS SP CORRESPONDENCE NO. 99-1017.

Be it ordained by the Sangguniang Panlungsod of Bacolod that:

Section 1 - The request of Patria P. Gensoli, MD, MPA, City Health Officer of the City Health Department, to increase her latest salary to one (1) grade higher prior to her compulsory retirement is hereby approved in pursuance to Section 2, Rule VIII of Republic Act 7305 otherwise known as the Magna Carta for Public Health Workers, to wit:

*"Section 2 . Highest Basic Salary upon retirement.
Three (3) months before compulsory retirement, the public health worker shall be granted on automatic one (1) grade salary increase in her basic salary and her retirement benefit thereafter shall be completed on the basic of her highest salary received and paid. Provided that the public health worker has reached retirement age and fulfilled the service requirements under the existing law".*

Section 2 - This ordinance shall take effect upon its approval.


