CITY ORDINANCE NO. 242

October 7, 1999

AN ORDINANCE APPROVING THE REDUCTION OF AMUSEMENT TAX OF THE PHILIPPINE BASKETBALL ASSOCIATION (PBA) GAME WHICH WILL BE HELD ON OCTOBER 23, 1999 AT THE LA SALLE COLISEUM FROM THIRTY (30%) PERCENT TO ONLY FIVE (5%) PERCENT WITH THE BACOLOD BOYS HOME AS ITS BENEFICIARY, PER LETTER-REQUEST OF DAVID M. VILLANUEVA, PRESIDENT, LA SALLE HIGH SCHOOL-BACOLOD KAISAHAN CLASS '70 DEVELOPMENT FOUNDATION, INC., DOCKETED AS SP CORRESPONDENCE NO. 99-1058, PROVIDED, THAT A REPRESENTATIVE FROM THE OFFICE OF THE CITY TREASURER BE MADE AVAILABLE TO MONITOR THE AFORESAID PBA GAME.

Be it ordained by the Sangguniang Panlungsod of Bacolod, that:

Section 1 - The amusement tax of the Philippine Basketball Association (PBA) game which will be held on October 23, 1999 at the La Salle Coliseum is hereby reduced from THIRTY (30%) PERCENT to only FIVE (5%) PERCENT with the Bacolod Boys Home as its beneficiary, per letter-request of David M. Villanueva, President, La Salle High School-Bacolod Kaisahan Class '70 Development Foundation, Inc., docketed as SP Correspondence No. 99-1058, PROVIDED THAT A REPRESENTATIVE FROM THE OFFICE OF THE CITY TREASURER BE MADE AVAILABLE TO MONITOR THE AFORESAID PBA GAME.

Section 2 - This Ordinance shall take effect upon its approval.


