RESOLUTION APPROVING ON FIRST READING THE PROPOSED ORDINANCE AUTHORED BY COUNCILOR AL VICTOR A. ESPINO, ENTITLED, "AN ORDINANCE AMENDING SECTION 9 (M), (N) AND 10 OF CITY ORDINANCE NO. 338, OTHERWISE KNOWN AS AN ORDINANCE REGULATING TRAFFIC, PARKING, TOWING AND OTHER TRANSPORTING OR COMMUTING ACTIVITIES IN THE CITY STREETS OF BACOLOD, ESTABLISHING THE ROUTE SYSTEM OF PUBLIC UTILITY VEHICLES (PUV's) AND TRUCKS, AND REDIFINING THE LOADING AND UNLOADING ZONES IN THE CITY OF BACOLOD", DOCKETED AS SP CORRESPONDENCE NO. 11-22-0716.


